Volunteer Release and Waiver of Liability Form

This Release and Waiver of Liability (the “release”) executed on _____ (date) by _____ (“Volunteer”) releases Goose Creek Memorial Band Booster Club, a nonprofit organization and existing under the laws of the State of Texas and each of its directors, officers, volunteers, and agents. The Volunteer desires to provide volunteer services for Goose Creek Memorial Band Booster Club and engage in activities related to serving as a volunteer. Volunteer understands that the scope of Volunteer’s relationship with Goose Creek Memorial Band Booster Club is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that Goose Creek Memorial Band Booster Club will not provide any benefits traditionally associated to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer’s services to Goose Creek Memorial Band Booster Club.

1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless Goose Creek Memorial Band Booster Club and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to Goose Creek Memorial Band Booster Club. I understand and acknowledge that this Release discharges Goose Creek Memorial Band Booster Club from any liability or claim that I may have against Goose Creek Memorial Band Booster Club with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to Goose Creek Memorial Band Booster Club or occurring while I am providing volunteer services.

2. Insurance: Further I understand that Goose Creek Memorial Band Booster Club does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of Goose Creek Memorial Band Booster Club in the event of injury or medical expenses incurred by me.

3. Medical Treatment: I hereby Release and forever discharge Goose Creek Memorial Band Booster Club from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with Goose Creek Memorial Band Booster Club.

4. Assumption of Risk: I understand that the services I provide to Goose Creek Memorial Band Booster Club may include activities that may be hazardous to me including, but not limited to Goose Creek Memorial Band Booster Club involving inherently the movement of heavy boxes/equipment during activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and Release, Goose Creek Memorial Band Booster Club from all liability.

5. Photographic Release: I do / do not grant and convey to Goose Creek Memorial Band Booster Club all right, title, and interests in all photographs, images, video, or audio recordings of me or my likeness or voice made by Goose Creek Memorial Band Booster Club in connection with my providing volunteer services to Goose Creek Memorial Band Booster Club.

6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that this Release shall be governed by and interpreted in accordance with the laws of the State of Texas. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
