I. Limitation of Liability:

- a. Limitations of liability releases Goose Creek Memorial Band Booster Club, a nonprofit organization and existing under the laws of the State of Texas and each of its directors, officers, volunteers, and agents. All individuals/sponsors and volunteers understand that the scope of the individual/sponsor/volunteer relationship with Goose Creek Memorial Band Booster Club is limited to a position and that no compensation is expected in return for services provided by Volunteer/Sponsor; that Goose Creek Memorial Band Booster Club will not provide any benefits traditionally associated to Volunteer; Sponsors limited to Donation Perks associated with the fiscal year and that each individual/entity is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of all services to Goose Creek Memorial Band Booster Club.
- b. Limitations and liability of website usage. By signing into Goose Creek Memorial Band Booster Club online site. All users hereby release any and all liabilities of Goose Creek Memorial Band Booster Club under the laws of the State of Texas and each of its directors, officers, volunteers, agents, and any departments and staff of Goose Creek Consolidated Independent District (GCCISD).
- c. Any and all understand and acknowledge that the Release discharges Goose Creek Memorial Band Booster Club from any liability or claim that he/she/entity may have against Goose Creek Memorial Band Booster Club with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services individual/entity provide to Goose Creek Memorial Band Booster Club or occurring while individual/entity am providing volunteer/sponsoring services.

Insurance: Further each individual/entity understand that Goose Creek Memorial Band Booster Club does not assume any responsibility for or obligation to provide him/her/entity with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. Individual/entity expressly waive any such claim for compensation or liability on the part of Goose Creek Memorial Band Booster Club in the event of injury or medical expenses incurred by me.
- e. Medical Treatment: Any and all individuals/entities Release and forever discharge Goose Creek Memorial Band Booster Club from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with Goose Creek Memorial Band Booster Club.
- f. Assumption of Risk: Any and all individuals/entities understand that the services they provide to Goose Creek Memorial Band Booster Club may include activities that may be hazardous to me including, but not limited to Goose Creek Memorial Band Booster Club involving inherently movement of heavy boxes/equipment during activities. As a individual/entity, they expressly assume risk of injury or harm from these activities and Release Goose Creek Memorial Band Booster Club from all liability.

1. President's personal information will not be displayed online with exception of Position, Name, and Personal Number.
 2. Any and all other information required to be filed for position is filed within the organizations secure files.
 3. Executive Board Member(s) have the right to opt-out of displaying images of individual person(s). Authorization to post images is required prior to the fiscal year.
- ii. Vice President I, Vice President II, Treasurer, Secretary
 1. All other Executive Board Member(s) personal information will not be displayed online with exception of Position and Name.
 2. Any and all other information required to be filed for position is filed within the organizations secure files.
 3. Executive Board Member(s) have the right to opt-out of displaying images of individual person(s). Authorization to post images is required prior to the fiscal year.
- c. Individual Volunteer Data Usage
 - i. Individual data information will not be displayed online, with exception of name and image that pertains to our group for one fiscal year ranging from June 1 to May 31.
 - ii. Individual volunteer may opt-out of images and name from being displayed on our site.
 - d. Charity Data Usage:
 - i. Sponsor(s) information such as company name and logos are used to display sponsorship at fundraiser events, football games, band events hosted by the Goose Creek Memorial High School Band/Color Guard, Formal events hosted by the Goose Creek Memorial Band Booster Club.
 - ii. Sponsors have the right to opt-out of specific information or images to be displayed.
 - iii. All forms completed by sponsor(s) are filed and secured. No vital information displayed online or electronically.

V. Data Security

- a. The organization utilizes a third party for credit card transactions. The two (2) parties are PayPal and Square. Please read PayPal and Square Disclaimers for transactions.
- b. All credit transactions charge a 1.2% to the Goose Creek Memorial Band Booster Club. The Goose Creek Memorial Band Booster Club, hereby notify sponsors and individuals a 1.2% will be added to all credit charges made through our third party.
